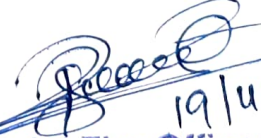

Subject to proper maintenance of fire fighting measures & fire fighting installations in good working condition and to impart training for 40% of employees / staff in basic fire fighting at R.A.Mundkur Fire & Emergency Services Academy, Bannerghatta road, Bengaluru at an earliest.

This renewal of fire safety compliance report is issued from the fire prevention and fire fighting point of view The Karnataka State Fire & Emergency Services Department is not responsible for the ownership of the land, its location and other disputes, which may arise in due course.
